- **Approval minutes from 6/10/20 meeting**
- Motion: Senator Clark moved to approve the Wednesday, June 10, 2020, meeting minutes as amended. Valerie Rochon seconded the motion. The motion passed unanimously.
- **Pop up Rooftop proposal—Russ Grazier**

This Rooftop Subcommittee is focusing on utilizing the top level of the Foundry Garage as an outdoor space open to the public for community gathering that would allow for local arts organizations to present performances outdoors and for local restaurateurs and featured retailers and artisans to have booths set up to sell food and wares, said Russ Grazier.

DPW Director Peter Rice said that details need to be worked out for that to happen. Any structures that go on the roof need to be held down from the wind. Independent generators will have to be provided. The City needs to work out the coordination of key components, but it looks like they are all things that can be dealt with, he said.

There has to be adequate warm water for restaurant staff to wash their hands as often as they need to (often). We have to make sure we are not creating a mass gathering, said Health Officer Kim McNamara.

- **Downtown Public Space—Mark Stebbins**

The stellar and passionate Portsmouth Pro Bono Design Group led by Bob White is meeting again on Sunday afternoon, June 14, said Mark Stebbins. Currently, their focus is on organizing the streets. They will be asked to participate in the garage design, but it is not certain they will take on the charge. Russ Grazier will represent the task force to the pro bono group.

- **Recommendations to Council**

James Petersen said that people are anxious about whether we are moving forward fast enough. The complexity of downtown issues is so big, perhaps going before the City Council on Monday, June 15, with partial information is the right decision. The urgency of businesses and their viability is something that is a concern to everybody.

City Manager Karen Conard responded it is best to hold off on making a big presentation to the City Council. This week, a short verbal update could be made. A well-organized packet of material can be presented the following week, June 22. What we have today is not “ready for prime time,” she said.

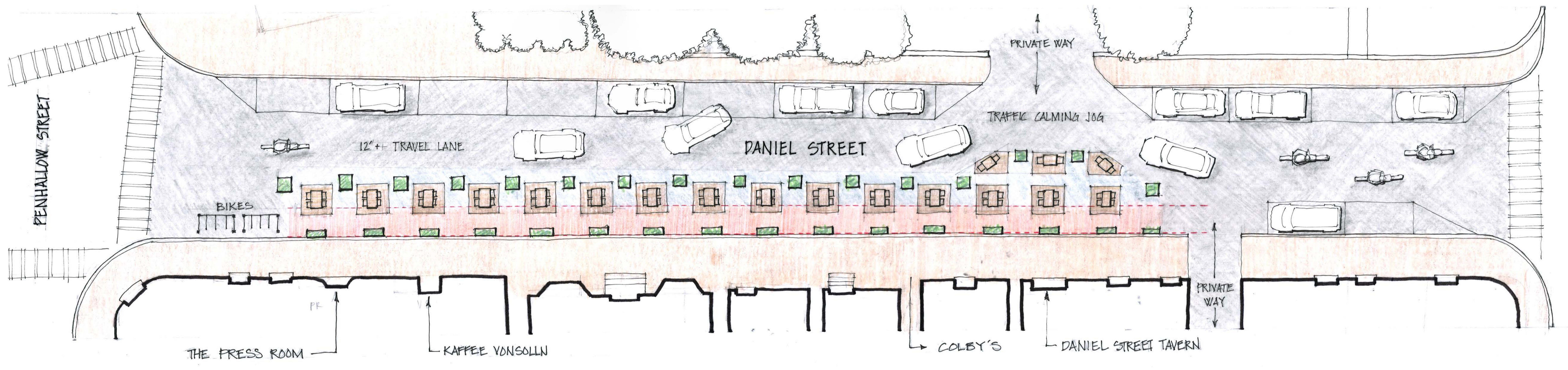

- Motion: Russ Grazier moved to adjourn. Karen Bouffard seconded the motion. The motion passed unanimously.




Daniels Street



Congress Street 2 lanes: Maplewood to Fleet



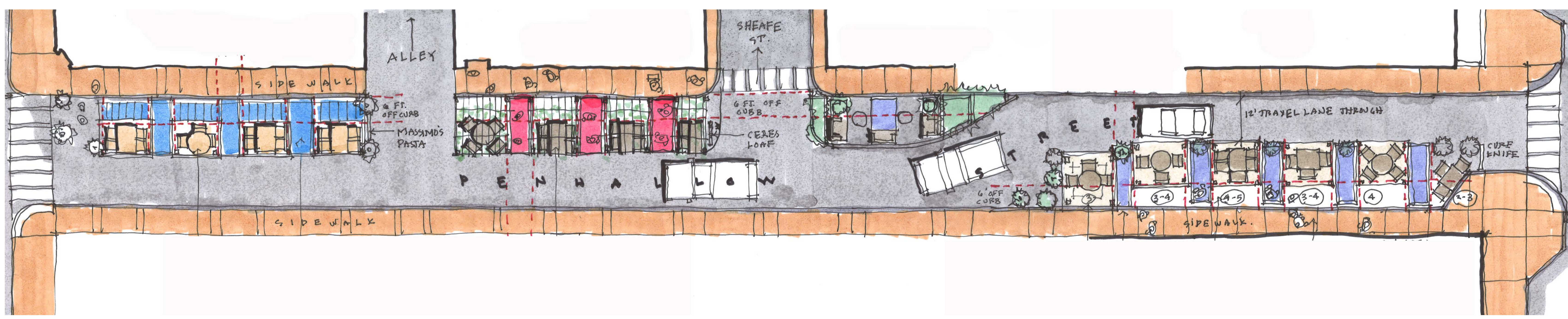
Congress Street 1 lane: Maplewood to Fleet
