Introduction

The Clipper Strong Fund is a grant program created in a partnership between the City of Portsmouth, NH and Coastal Economic Development Corporation, a 501(c)(3) nonprofit. The goal of the Fund is to aid small, independent businesses within the City of Portsmouth in their efforts to address the severe business impacts caused by the COVID-19 crisis and for those businesses that may have fallen through the cracks of public financial assistance. Phase 1 of the Fund consisted of the creation and distribution of re-opening kits, and those kits are being distributed City-wide. Phase 2 will involve small, direct grants to businesses to help with specific COVID-19-related needs. Funds will be limited, and it is expected that demand will exceed Fund resources.

Fund Criteria

1. Small, independent businesses with 10 or fewer employees
2. Applicants must have been in business in Portsmouth for at least 6 months prior to March 13, 2020 (date of emergency declared in NH).
3. Eligible uses: Public or employee safety modifications, inventory, new equipment required to operate under existing guidelines, rent, utilities, employee benefits, and marketing materials (including printed or online media and disposable items for public information)
4. Grants up to a maximum of \$500
5. Paid on evidence of invoices and/or quotes

Application Requirements and Approval Process

It is the goal of the Clipper Strong Fund Committee that all applications it reviews will be anonymous. Applicants are expected to submit a full application, including the Cover Page and the body of the application (Pages 1 and 2). All applications will be assigned an "Application Number" before being submitted to the Committee for consideration. Submittals are limited to the 3 application pages.

Applications will be accepted only via email. Send completed applications to clipperstrong@gmail.com.

The deadline for submittal of applications will be 4 PM on October 1, 2020 and it is expected that grant awards will be made on or around November 2, 2020. Questions regarding the application process may be sent to dgray@coastaledc.org
