The City of Portsmouth and NH Theatre Project present a reading of the play *Final Thoughts* by Tim Barretto, and a community discussion on the topic of Suicide & Self-Harm on Wednesday, October 14 at 6:30 pm via Zoom. Co-sponsored by Seacoast Mental Health Center, this program is part of New Hampshire Theatre Project's Elephant-in-the-Room Series® (EITR). *Final Thoughts* will be performed by Bill Humphreys, Peter Josephson, and Teddi Kenick-Bailey, along with Portsmouth actors Genevieve Aichele, Blair Hundertmark and CJ Lewis. Immediately following the reading, NHTP's Artistic Director Catherine Stewart will facilitate a community discussion designed for teenagers and adults with panelists Dennis Walker, Director of Emergency Services at Seacoast Mental Health Center; playwright Tim Barretto; and Lt. David Keaveny from the Portsmouth Police Department. The Portsmouth High School guidance department is also providing assistance during the program for those who might want to discuss issues the play or conversation might trigger.

- Congressman Chris Pappas has been serving as the U.S. Representative for New Hampshire's 1st Congressional District since 2019. He previously served on the New Hampshire Executive Council from 2013 to 2019, representing District 4.
- Matt Mowers served as Senior White House Advisor at the State Department. Before serving in President Trump's State Department, Mowers advised Republican leaders as a senior official for the Trump-Pence Presidential campaign, and as Executive Director of the New Hampshire Republican Party.

Attendees via Zoom will be seated in two separate "rooms" to interact directly in a facilitated discussion with the candidates. After approximately 25 minutes of Q&A with one candidate, the candidates will shift into the opposite "room" so attendees have the same amount of time with each candidate. This is neither a debate nor a panel discussion, but an opportunity for voters to ask questions and share concerns with both of the candidates. The Roundtable is presented by Eversource.

Halloween Guidelines:

The hours permitted for trick-or-treating will be Saturday, October 31 from 3 to 6 pm. The schedule for trick-or-treating in Portsmouth is subject to change, based on the COVID-19 infection rates being reported in late October.

The City Health Officer asks that families not travel town to town or invite friends or family from other towns to come to Portsmouth as that reduces the risk associated with mixing households in close groups. The City's Emergency Services team also reminds residents that gathering in groups, in indoor settings with reduced air flow, is highly discouraged due to the greater risk of COVID-19 transmission.

Residents are asked to follow this guidance compiled from advice issued by the State of New Hampshire, the Federal Centers for Disease Control and Prevention, and the New Hampshire Municipal Association:

- **Travel in family groups, only (not with members of other households).** Small children should be accompanied and supervised at all times.
- **Maintain at least a six-foot distance** between people not from the same household.
- Wear face coverings (standard Halloween masks are not sufficient as they typically do not cover the mouth).
- Bring a small bottle of **hand-sanitizer** with you and use it often.
- Residents who do not want to participate should leave their front house lights turned off or put a sign on the driveway or sidewalk. Trick or treaters should respect that notice.
- **No direct distribution of treats, please.** Children and those providing candy should maintain physical distance.
 - Distribution points should be cleaned regularly throughout the three hours of trick or treat.
 - Put treats in individual paper bags, or spread out on trays rather than using a communal bowl and place on a table on the front walk, porch or driveway.
 - Be creative! Candy slides or tubes? Who will have the best idea for distributing treats?

WATER RESTRICTIONS STILL IN EFFECT – The DPW Water Division is restricting Water customers to use for watering lawns and gardens only on odd-numbered days, between midnight and 10 am. There should be no outdoor watering on even-numbered days. The recent rain far from makes up for the lack of rain since June. The Portsmouth Fire Department announces that no new permits will be issued until further notice. Also, the Fire Chief urges residents with Class 1 and 2 backyard fire permits to use extreme caution when kindling fires, to not burn if it is windy and to be extra sure the fire is extinguished before leaving it for the evening.

FLU SEASON AHEAD! FLU SHOTS NOW AVAILABLE -- Public health officials are urging people to get flu shots this year. Flu shots are now available in the Portsmouth at:

- ClearChoice MD 750 Lafayette Rd 603.427.8539. Flu shots available - can walk in, but preregistration will save time.
- Rite-Aids: Flu shots available; can walk in.
- CVS: 674 Islington St 603.431.0234 Flu shots available; prefer appointments be made due to waiting area size.

All of the above said that flu shots are covered at no cost with most insurances and Medicare.

PORTSMOUTH VOTING CENTER IN CITY HALL OPEN WEEKDAYS THROUGH NOV 2. POLLING HOURS ON NOV 3: 8 AM TO 8 PM --The Portsmouth Voting Center in the Eileen Dondero Foley Council Chambers in City Hall operates on the same schedule as City Hall:

- Monday 8 am to 6 pm
- Tuesday 8 am to 4:30 pm
- Wednesday 8 am to 4:30 pm
- Thursday 8 am to 4:30 pm
- Friday 8 am to 1 pm

The Voting Center allows residents to take advantage of the following services offered by the City Clerk's Office: Voter registration, Obtain Absentee Ballot, Return Absentee Ballot. Anyone who is a "delivery agent" returning an absentee ballot will be required to show picture identification and complete a form. Due to COVID-19 restrictions, the Center cannot accommodate voting within the City Hall Municipal Complex. **The City Clerk's Office staff will also be available outside of City Hall on Saturday, October 17 and October 24, from 9 am to 12 noon, to collect absentee ballots (only from voters who are returning their own ballots).** Please contact the City Clerk's office at 610-7245 with any questions.

MAPLEWOOD AVE. DOWNTOWN INTERSECTION CROSSING SIGNALS -- New Maplewood Ave downtown intersection pedestrian crossing signals are now working. Pedestrians and motorists downtown at the intersections of Maplewood Avenue and Deer Street, Hanover Street and Congress Street now experience new pedestrian-crossing patterns thanks to an upgrade in the traffic signals. Previously, all vehicle traffic stopped at the same time for pedestrian crossing in all directions. That cycle caused delays. The new timing gives pedestrians the WALK signal while the traffic moving parallel with them has the green signal. Turning traffic will be required to yield to pedestrians in the crosswalk. New signs posted at each intersection and electronic message boards will alert drivers to the need to yield to pedestrians when turning at intersections. **Make sure you press the button for the crosswalk you want. There are now two buttons.**

DPW PROJECTS THIS WEEK:

ISLINGTON STREET DETOUR BETWEEN BARLETT & CASS STREETS -- Traffic flow will be reduced to one lane of one-way westbound traffic between Cass Street and Bartlett Street. Eastbound traffic on Islington will be detoured onto Jewell Court and around the work zone via Brewery Lane and Cass Street. Flaggers and/or police details will be present to help direct traffic. Drivers should expect minor delays. Parking restrictions will be in place at all times along the detour until the winter shutdown between mid-December and next April and will resume until the project is completed in June 2021. BANFIELD ROAD CONSTRUCTION CLOSURE – The section of Banfield between Heritage Ave and Ocean Rd. is now closed due to construction. Drivers are detoured to Lafayette Rd. SOUTH STREET PAVING – Paving complete, just need to stripe the section of South Street between Junkins Ave. and Marcy Street this week. No parking allowed in this section between 7 am and 5 pm. Residents with on-street parking should park in the lower lot at City Hall.

KEARSARGE & MARKET STREET BRIDGES – Traffic reduced to one lane, police detail and flaggers in place. Work to upgrade the traffic signals at the downtown intersections with Maplewood also continues.
