### **SBA LOANS FOR THE SMALLEST SMALL BUSINESSES -- EXCLUSIVE APPLICATION OPPORTUNITY OPENS TODAY: FEB 24**

Following directions from the Biden Administration, the Small Business Association (SBA) is working to:

- **Establish a 14-day, exclusive PPP loan application period for businesses and nonprofits with fewer than 20 employees**
- Include sole proprietors, independent contractors, and self-employed individuals and additional support in the PPP's funding formula
- Eliminate an exclusionary restriction for small business owners with prior non-fraud felony convictions;
- **Eliminate PPP access restrictions on small business owners who have**

**struggled to make federal student loan payments** by eliminating federal student loan debt delinquency and default as disqualifiers and

- **Ensure access for non-citizen small business owners who are lawful U.S. residents** by clarifying that they may use Individual Taxpayer Identification Number (ITIN) to apply for the PPP.

**The 14-day exclusivity period will start on Wednesday, February 24, 2021 at 9 a.m., while the other four changes will be implemented next week. For advice and assistance, [click here](#) to contact the NH Small Business Development Center.**

**COVID-19 VACCINE ADMINISTRATION IN NEW HAMPSHIRE** – As of February 24, NH had received **344,165** doses of vaccine and had vaccinated **274,267 (15.5% of the population has received 1 or more doses)**. The dose balance ensures vaccine for those scheduled to receive first or second doses in the current Phase 1A-1B. For the vaccine tracker, by state, click here:

**AGE 65+ VACCINATION APPOINTMENT WEBSITE** -- Scheduling your Dose 1 appointment online at <https://vaccines.nh.gov> is the fastest, most efficient way to do so and is highly encouraged. The website is designed to

**Those 65+ who do not have Internet access and need assistance can call Brinn Sullivan [603-610-4433] at the Portsmouth Senior Activity Center.** Please note that the City is not setting up vaccination appointments. Brinn is simply available to help seniors over the telephone to register on the State website. **Brinn is also assisting seniors who need transportation to the local vaccination sites.**

**Everyone receiving the first dose now receives a vaccination card that includes a scheduled appointment for Dose 2. All you need to do is show up for Dose 2.** If you need to change that appointment, you can do so by calling the 211 hotline.

**IF YOU NEED TO SCHEDULE DOSE 2 YOURSELF** – Return to the CDC VAMS website <https://vams.cdc.gov/vaccineportal/s/login/?startURL=%2Fvaccineportal%2Fs%2F&ec=302> where you made your Dose 1 appointment. Find the email you received when you registered for Dose 1. Search your inbox for an email from [vams@cdc.gov](mailto:vams@cdc.gov) then log in and schedule Dose 2.

**CHANGING DOSE 1 APPOINTMENTS** -- Those whose Dose 1 appointments are not until April can cancel those and then CALL 211 to speak to a NH DHHS agent who can arrange for an earlier appointment. The 211 wait-times can be 40 minutes or more, but be patient. **Operators are available from 6 am to 10 pm, 7 days a week.**

**PERMITS FOR OUTDOOR DINING & DOMES/IGLOOS– APPLICATION PROCESS NOW OPEN** -- City staff started reviewing and renewing applications for the 2021 outdoor dining season as of February 1.

- **Those approved for the 2020 season DO NOT need to reapply.** They will be contacted directly by the City to renew their licenses for the upcoming season.
- **Businesses who were not approved in 2020 and wish to operate an outdoor cafe on public property in 2021 must apply for approval** by submitting an application through the City's Viewpoint online permitting portal. <https://portsmouthnh.viewpointcloud.com/categories/1076/record-types/6431>
- **Anyone opening a new restaurant, is an existing restaurant that is expanding or adding an outdoor area on private property, or who seeks to place tables, chairs or signage on a public sidewalk** with no food or alcohol service, please click here for more information. <https://portsmouthnh.viewpointcloud.com/projectTemplate/4>
