**OPENING MON JUN 7: SPINNAKER POINT** Spinnaker Point Adult Fitness Center reopens on Monday, June 7 at 6am. All members and new members can register upon their first visit. The City closed Spinnaker Point a year ago as a precaution to protect against the spread of COVID-19. One of the concerns that needed to be addressed before reopening was an evaluation of the air circulation inside the facility. Since then, the City has made repairs that allow the air-handling system to function without the significant and unbudgeted investment that was originally anticipated to improve or replace it. Equipment in the fitness room will be positioned to allow for sufficient distancing and other protocols will be in place. **Hours for Spinnaker Point Adult Fitness Center are Mon-Fri, 6am-8pm; Sat-Sun, 7am-4pm.** Please call 603-766-1483 for more information.

**STARTING TODAY JUN 3: PORTSMOUTH NAVAL SHIPYARD BLASTING OPERATIONS COMMENCE FOR DRY DOCK #1** –Operations will be conducted during daylight hours Mon-Sat from June 3, 2021 until Feb 2022. The actual detonations will occur once or twice a day, most frequently in the late afternoon. In accordance with standard/industry construction practices, the contractor has incorporated a number of safety initiatives to ensure life, property, and the environment are not endangered.

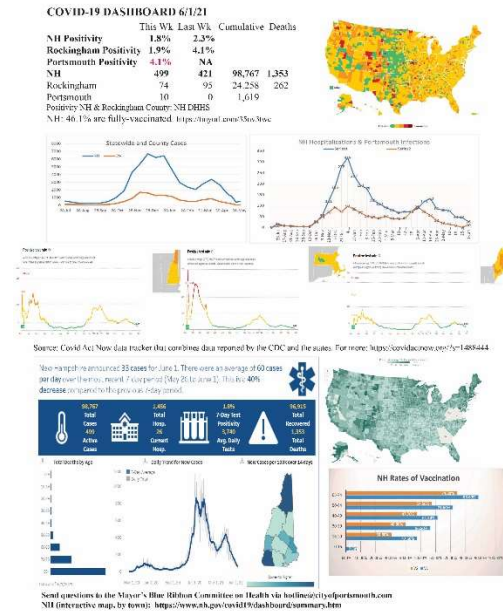

**NH DHHS GUIDANCE FOR FULLY-VACCINATED PEOPLE –** Until all counties have reduced community transmission and more of the

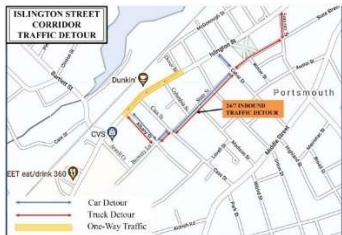

**NH DEPT OF EMPLOYMENT SECURITY BACK TO WORK INCENTIVES** – All those receiving NHDES benefits must again show proof they are seeking work. NH is ending the Federal supplement \$300 stipend on June 19. **Anyone who is receiving unemployment benefits and finds work as of May 18, is eligible for a \$500 bonus for part-time work or \$1000 for full-time work.** Proof of 8 weeks employment is required to apply. Those receiving more than \$25/hour are ineligible.

**ISLINGTON STREET CORRIDOR DETOUR NOW IN PLACE 24/7** – Ledge drilling continues. Note that Sunoco station is open throughout. Inbound *car traffic* detours from Islington to Albany to State to Cabot. Inbound *truck traffic* detours from Islington to Albany to State to Summer – or stays on Rte. 33/Middle Road, all the way inbound to Middle Street. Outbound traffic only on Islington.
