Minutes - October 16, 2023 -- Portsmouth Arts and Nonprofits Committee

Russ called the meeting to order at 12:05 PM

Due to lack of in-person quorum, no minutes were approved and no other votes were taken.

Russ reported that the report from the Finance/Tax Assessors office on non-profit taxing is on hold until 2024.

1. Cultural Plan Subcommittee Update:

Jeff Cooper, Russ Grazier, Jason Goodrich and Genevieve Aichele discussed a tentative arts organizations tour for the ARG representatives on Tues/Wed Oct 17-18. The agenda for the joint committee work session scheduled for Thurs Oct 19 is intended to initiate the transition between ARG's community outreach/data collection efforts and the initial draft of the Cultural Plan. The debrief includes:

Barbara reiterated that the Cultural Plan Subcommittee is "all over the project" and is investing a significant amount of time and effort.

2. AFTA Update (Robin Albert):

AFTA reported its national data on October 12. As soon as the spreadsheet of participating organizations is confirmed the subcommittee will share the Portsmouth data with them – but is requesting that the information be shared only with sponsors or stakeholders and not with the public. The public release of data will coincide with Randy's visit Jan 11-12, 2024.
